10. GROUP STAND

The Exhibitors must not transfer, dispose of part with or otherwise sublet the whole or any part of his site, whether for financial consideration or otherwise the exhibitors must, if he is an agent distributor or license-should-state at the-time-of-contract the names of the principal to represented, This dose not prohibit an exhibitors displaying the products of a principal for whom he becomes agent, distributor of license after the time of contract with the prior written permission from the organisers.

11. FORCE MAJEURE

Under the conditions of force majeure which also include strike, bandh natural calamities and other events and decision beyond the control of the organisers, the organisers are entitle to alter the dates, duration or cancellation of the entire fair, in the event of cancellation of the fair, the participation charges will be refunded after deduction of the costs already incurred by the organisers.

At no cost cancellation is allowed. No refund will be done to the participant.

12. PROMOTION DURING THE EXHIBITION

Exhibitors are reminded not to place stickers, signs or posters anywhere in the hall other than within their own stand. likewise Exhibitors representative may not distribute brochures, invitations etc along the gangways or near the entrance. this is unfair to other exhibitors and an inconvenience to visitors.

13. RAW SPACE STALL SITE (inside hall)

The minimum size for a Raw space stall site is 36 sq.m. No restrictions are placed upon raw space stall designs provided they meet the following criteria :-

- Stall designers are particularly requested to avoid designs which block or box-in other exhibitors stalls, gangways, fire point, extinguishers or emergency exits.
- No stall should be designed to go beyond 4M in height without specific consent of the organisers. exhibits and display should not exceed this limit.
- Exhibitors without a platform are required to ensure that free access is given for the running of necessary cable across their stalls.

TERMS AND CONDITIONS

(g) Welding is strictly prohibited.

(h) No plaster of paris (POP), brick work, melamine polishing or carpentry work will be allowed inside the halls. The area of the booth must not exceed the allotted area.

14. CO-EXHIBITORS/SUB-EXHIBITORS AND SHARED STANDS

Without the approval of the organizer it shall not be permitted to provide an allocated stand or parts thereof gratuitously or non-gratuitously to third parties. Companies which are not listed in the registration may not be advertised on the stand. The lessee must apply to the organizer in writing for the inclusion of a co-exhibitor/sub-exhibitor. After the written approval of the organizer in text form, the lessee shall pay a co-exhibitor/sub-exhibitor fee to the organizer in the amount determined for the individual event. The exhibitor shall be responsible for ensuring that the co-exhibitors and sub-exhibitors acknowledge the General Terms of Participation and all obligations resulting from them. Co-exhibitors which become direct contractual partners of the organizer in addition to the exhibitor shall be liable with the exhibitor as joint and several debtors. Larger shared stands of exhibitors can be approved by the organizer if they can be integrated into the technical structure of the event. Apart from that, all provisions shall apply to every exhibitor. If a stand is allocated to two or more exhibitors in conformity with their joint application, each of these exhibitors shall be liable to the organizer as joint and several debtors. The exhibitors exhibiting jointly should name a joint representative on the registration form. Any inclusion of co-exhibitors/sub-exhibitors without approval shall entitle the organizer to terminate the contract with the exhibitor without notice and to have the stand cleared at the expense of the latter. In this respect, the exhibitor waives its rights arising from unlawful interference with possession.

15. BUILD-UP STALL

The minimum size for a built-up stall is 9 sq.m. The built-up stall contractor will put-up the exhibitors name and stall number on the fascia board. it is not

allowed to attach any additional texts, logos, etc, on the fascia board.

16. ELECTRICAL INSTALLATION

All on-site electrical installation MUST be carried out by the officially appointed electrical Contractor. All prefabricated electrical fittings will be subject to an inspection by the official contractor, before connection to the mains supply. payment for extra electrical load and consumption should be made to the organisers.

17. EQUIPMENT INTERFERENCE

No equipment can be operated which makes excessive noise or causes electrical interference or annoyance to other exhibitors in this matter the decision of the organisers will be final.

After the written approval of the organizer in text form, the lessee shall pay a co-exhibitor/sub-exhibitor fee to the organizer in the amount determined for the individual event. The exhibitor shall be responsible for ensuring that the co-exhibitors and sub-exhibitors acknowledge the General Terms of Participation and all obligations resulting from them. Co-exhibitors which become direct contractual partners of the organizer in addition to the exhibitor shall be liable with the exhibitor as joint and several debtors. Larger shared stands of exhibitors can be approved by the organizer if they can be integrated into the technical structure of the event. Apart from that, all provisions shall apply to every exhibitor. If a stand is allocated to two or more exhibitors in conformity with their joint application, each of these exhibitors shall be liable to the organizer as joint and several debtors. The exhibitors exhibiting jointly should name a joint representative on the registration form. Any inclusion of co-exhibitors/sub-exhibitors without approval shall entitle the organizer to terminate the contract with the exhibitor without notice and to have the stand cleared at the expense of the latter. In this respect, the exhibitor waives its rights arising from unlawful interference with possession.

15. BUILD-UP STALL

The minimum size for a built-up stall is 9 sq.m. The built-up stall contractor will put-up the exhibitors name and stall number on the fascia board. it is not allowed to attach

any additional texts, logos, etc, on the fascia board.

16. ELECTRICAL INSTALLATION

All on-site electrical installation MUST be carried out by the officially appointed electrical Contractor. All prefabricated electrical fittings will be subject to an inspection by the official contractor. before connection to the mains supply. payment for extra electrical load and consumption should be made to the organisers.

17. EQUIPMENT INTERFERENCE

No equipment can be operated which makes excessive noise or causes electrical interference or annoyance to other exhibitors in this matter the decision of the organisers will be final.

18. DAMAGE TO STAND STRUCTURE AND EXHIBITION PREMISES

No person under any circumstances shall out into or through any floor covering or wall nor alter any stand service structure except when authorized in writing by the organisers.

19. STAND CLEARING

During the exhibition days the organiser will be reasonable for the daily cleaning of the stand carpets and gangways. during the build up/dismantling periods, independent contractor appointed by exhibitors are responsible for the removal of the stand building/ dismantling materials and rubbish.

20. CANCELLATION

If any exhibitor cancels his booking before **August 15, 2022**, 25% of the total stall charges will be forfeited. No refund of advance on cancellation after 15th August 2022.

21. GOVERNING LAW AND JURISDICTION

Disputes if any, shall be governed and construed in accordance with Indian laws and shall be subject to jurisdiction of Hyderabad.

22. UNFORESEEN OCCURRENCES

In the event of any occurrence not foreseen in these rules & regulations, the decision of the organiser shall be final.

23. ADVERTISING IN FAIR VENUE

(a) Printed matter and advertising material may be displayed / distributed only in their own stall and not in the hall gangways or outside the exhibitions hall.

(b) Moving, accoustic advertising and music are prohibited. The organisers shall be entitled to intervene and discontinue or remove the equipment in case of

disturbance.

24. PHOTOGRAPHS AND FILMS

Organisers have exclusive right to take photographs and films of the exhibition stands. Prior permission of the Organisers will be essential for taking photographs and films by exhibitors for areas other than their own stands

25. GENERAL

(a) Participants shall use the space only for exhibition purpose & not for cooking, staying or washing

(b) The decision of the chairman. POULTRY INDIA will be final and binding in regard to enforcement of these rules & regulations as laid down by the organisers.

(c) The organisers reserve the right to alter the floor plan, allot / reject the stall, alter the application, Stall charges, Terms & conditions.

(d) Product Demonstration if any should be held with sufficient safety measures. Demonstration should be so arranged that metal burrs, Concrete, Wood and other scrap emanating out of demonstration should not fly and pose hazard to anyone. Exhibitors should conduct demonstration inside transparent enclosure and ensure that the waste be collected within the allocated stall space only. The exhibitors will be solely responsible for collection and cleaning of waste collected from the demonstration.

(e) All display item should be positioned within the allocated stall space only. any violation from this will not be entertained and the organisers reserve the right to close the stall.

26. HANDLING FACILITIES

The services of cranes and forklifts through authorised contractors will be available at extra cost if required

The Participant must mention in the application form the details of weight of the exhibits to be handled. this cost has to be settled directly with the contractor.

27. ACCEPTANCE OF RULES

The very fact that an exhibitors participates in the exhibition as an exhibitors, it will be presumed without any dispute that he/she, his/her company/ organisation has read the rules and regulation formulated by the organisers and as printed above and irrevocably confirms to abide by them. this is applicable to each and every one participant irrespective of the amount of percentage of payment made to the organisers and includes participants, exhibitors / co-exhibitors as well as companies / organisation of the complementary stalls, irrespective of the fact if they have signed or not signed the registration form or any other document.
